SRO 44 - In exercise of the powers conferred by section 283 of the Jammu and Kashmir Municipal Act, Samvat 2008 (VIII of 2008), the Government hereby declare that within the local areas of village Nandwal Mora, Kalian, Marchangi and Khour, Tehsil Akhnoor, District Jammu, the boundaries whereof are described in the sub-joined schedule, improved arrangements are required to be made with respect to the matters upon which Municipal fund may be expended and accordingly the said area shall constitute a Notified Area.


