5.	Did GAD passed any further direction /communication regarding this fake board to other departments of UT after Circular 31 if 2019 was issued in year 2019.	-do-
6.	Kindly make the difference clear whether SRO-339 of 2005 was introduced for candidates pursuing Higher Education through un-registered Universities at graduate/post graduate level or passing Secondary/Senior Secondary level.	-do-
