

In this regard the requisite information find out as per copy of Master Plan PDA which has been made available to this office by the Patnitop Development authority is hereby given as under:

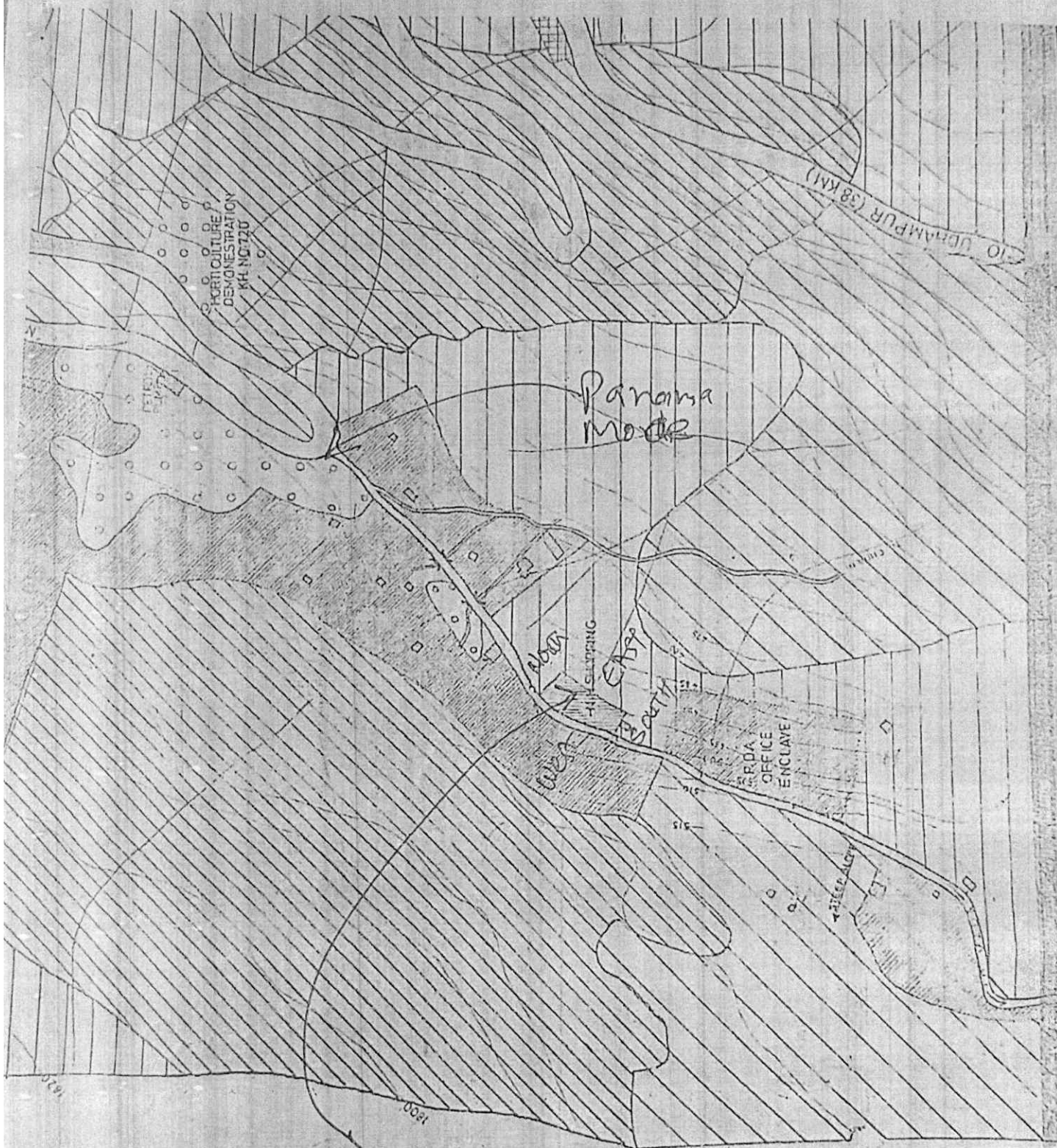
