The park should be properly integrated with the High School activities. Viewing decks along the park boundary to be developed and a small nursery may be located here.

Earlier the PDA office was located with housing. However, in discussion with PDA, it has now been proposed

- a) PDA office with CEO Residence at Kh. No.180/1.
- b) PDA officers enclave at Kh. No. 780
- PDA staff housing at Kh. No. 720 could be provided in the proposed residential area at a convenient location.

Hotels at Kh. No. 1402/165 & 1475/1386/154 (proposal already submitted to PDA)

NH shopping on the downhill of road from Panama mode to Mada.

A site for residential school has now been proposed. This site is situated on the NH-1A about 1.3km from PDA Office opposite Beacon office. An area of about 8.0 acres has been allocated, well before the existing HT line/tower.

Parking in front of Gold Flinch by taking off a connection ramp down below and reconnecting with the NH-1A. This may be developed in two tiers in future. Also a small parking near this site is proposed crossing the nallah on NH-1A.

- Parking has been banned on NH 1A near Kud Bazar.
- Extensive afforestation to be undertake along NH-1A. The existing waste land on the east of NH-1A be put under afforestation.
- Fire station and Telegraph Office beside Massu Shop
- Primary Health Centre along NH-JA opposite Kud View Restaurant on the down hill side.
- A trekking route connecting Kud and Sanasar Patritop road is also being incorporated
- The existing poultry farm on NH-1A before Kud on the uphill side will be allowed to develop as a full fledged centre keeping check on pollution and obnoxous smell.

The development of Mall road to be taken up at the first stage with development of parking, PDA office with CEO residence and officer/staff housing.

l'ichere has been divided into two areas as Pichote I and Pichote II. While Pichote II is lying down hill and presently there is no scope of demand of development.
